Security Camera Application

To better serve the community and to help protect the Waldo District, the Waldo Community Improvement District (CID) created a Security Camera Grant Program. The Program reimburses 50% of expenses UP TO \$1,000 for the installation of a minimum of four exterior cameras. Reimbursement will be given to Waldo Area CID members who meet these qualifications:

- Applicants MUST have the property owner's permission.
- Applicants MUST own a business within the Waldo Area Community Improvement District boundaries.
- Applicants MUST install at least four cameras on the exterior of the property noted on the application.
- Applicants MUST register the cameras with the Kansas City, Missouri Police
 Department's "WatchKC" program, which allows the police to contact registrants to see if
 any possible evidence was captured. Someone from KCPD will then arrange to obtain
 the footage at a time that is convenient for you.
- Cameras MUST be installed within 30 days after being approved
- Applicants MUST apply for reimbursement within 60 days of approval.

Please note: The Waldo Area Business Association (WABA) will NOT have access to your cameras, however, if needed the WABA staff may ask for footage. We would request camera footage pertinent to the CID and its security personnel. **We will not request footage from interior cameras if any are installed.**

- Applicants must purchase a camera system/contact a camera installation vendor and prepare their property for installation.
- The CID will send applicants an Approval Notice within 10 business days following submission of a completed application.
- The CID will issue a reimbursement check after receiving canceled checks and invoices, or other proof that the camera system has been purchased AND installed, and registered with WatchKC (https://www.kcpd.org/get-involved/watchkc/register/).

I understand that by applying for this program:

- I own the business at the address listed above and my business is within the boundaries of the Waldo Area CID.
- I have the permission of the property owner to install security cameras (if the property owner is different from the applicant).
- Once installed, the cameras will remain on the property for which I am applying. The camera may not be removed or transferred to another property, even if you no longer own/lease the property.
- Each property, as defined in the Security Camera Grant application, is eligible for the grant once every 5 years.
- I will prepare the property for the installation of cameras, as required, to ensure proper installation. Site preparation is not an allowable expense within the Security Camera Grant.
- I understand that camera installation may require exterior drilling and wiring installed throughout the building to mount the cameras and I will not hold the CID responsible for any damage during or following installation as a result
- I understand that my statements are subject to verification. I will report, immediately, any changes in the information provided on this application.
- I declare that the information on this application is true, correct, and complete to the best of my knowledge.
- I understand that I am giving Waldo Area Business Association access to my external cameras when needed.
